

During FY 2015, Southwest Virginia Acute hospitals reported over \$10.3 BILLION in gross patient revenue and \$277 MILLION in gross charity care.

In the same year, net patient revenue (money the hospitals received for patient services) was reported at \$3.3 BILLION, while charity care at cost was calculated at \$83 MILLION. Charity care at Medicare cost was calculated at \$67 MILLION.

CHARITY CARE PROVIDED BY ACUTE HOSPITALS IN SOUTHWEST VA

The 2017 Virginia General Assembly passed HB2101 which was approved as Chapter 791 and defines Bad Debt, Charity Care and details that charity care values be reported based on the provider reimbursement methodology utilized by the Centers for Medicare and Medicaid Services (CMS) among other changes. Whereas reporting regulations and guidelines have not yet been established, VHI collaborated with the Virginia Hospital and Healthcare Association (VHHA) and the Virginia Department of Health (VDH) to develop this charity care report. Charity care values were reported as gross dollar amounts by hospitals. VHI used the below formulas to calculate charity care at hospital cost and at Medicare cost in an interim effort to provide a more in-depth and detailed look at the value of charity care provided by Virginia hospitals.
